

- ▶ Ethnic products like papads, pickles, etc.
- Health food and nutraceuticals
- ▶ Food enzymes, ingredients, etc.
- Canned products
- Soup powders

NOTE: As per existing SEZ rules, units in SEZ can import both raw materials and semi-processed products duty-free for value addition with no additional costs if they are meant for exports. However, DTA sales of such finished products will attract levies as per duties prevalent at the time of sales. Hence immense possibilities could be explored by units who can import raw materials like cocoa powder, cheese, wheat, etc. and use the fiscal benefits of the SEZ policy and economical labor to export to other countries at competitive prices.

Definition of Special Economic Zone:

"Specifically delineated, duty-free enclave and shall be deemed to be foreign territory for the purposes of trade operations and duties and tariffs." (EXIM Policy 2000, Chapter 9, Para 30)

SEZs are geographic regions where manufacturers and other enterprises operate under more liberal taxes, tariffs and duties than other regions in the country. Approximately a dozen countries have SEZs. Typically their goals are to enhance foreign investment, bolster exports and help domestic enterprises compete globally.

The policy for setting up SEZs in India was put into place in January 2006. Today there are approximately 29 different types of industries / activities operating SEZs in India. Pearl City FoodPort represents the first SEZ in India solely dedicated to the food processing industry.

- Exemption from customs duty on import of capital goods, raw materials, consumables, spares, etc. No import license is required even for secondhand machineries.
- Exemption from excise duty on procurement of capital goods, raw materials, consumable spares, etc. from the domestic market.
- Income tax exemption as per Sec. 10A of IT Act. Graded income tax holiday for 15 years. Carry forward of losses permitted. Write-off of unrealized export bills up to 5%.
- 100% FDI through automatic route barring few sectors, no cap on foreign investments for SSI reserved items. Exemption from industrial licensing requirement for items reserved for SSI.
- Facility to retain 100% FE receipts in Exchange Earners Foreign Currency (EEFC) A/c, facility to realize and repatriate export proceeds within 12 months. Capitalization of import payables.
- Re-export of imported goods found defective, goods imported on loan basis, etc.

- Commodity hedging by SEZ units permitted.
- Profits allowed to be repatriated freely without any dividend balancing requirement.
- Domestic sales of full duty subject to import policy in force.
- No fixed wastage norms, facility available for sub-contracting, contract farming, etc.
- Job work on behalf of domestic exporters for direct export allowed.
- In-house customs clearance. No routine examination by customs of exports and imports cargo.

NOTE: These are some of the benefits as per the SEZ policy of the government of India. However, investors are advised to kindly check and more information and latest undates

Important riders

- The unit should become a net forex earner in three years time from the date of commercial operation.
- Supplies from DTA to SEZ units treated as deemed exports.
- Duty-free goods to be utilized in five years.
- All DTA sales would be subject to conditions as per import policy.
